

14. DESCRIPTION OF AMENDMENT/MODIFICATION (Organized by UCF section headings, including solicitation/contract subject matter where feasible.)

The purpose of this modification is to transfer the FHWA FMIS portion of the services from this task order onto Task Order No. ENTR0500006.

This modification decreases the estimated cost and actual funding limitation by \$97,948.66 for the second option year.

Notwithstanding the previously negotiated total of \$2,650,712.51, in performing this contract, the contractor is not authorized to make expenditures or incur obligations in excess of \$2,552,763.85 without the prior written approval of the Contracting Officer.

Except as provided herein, all terms and conditions of the document referenced in item 9A or 10A, as heretofore changed, remains unchanged and in full force and effect.
