

TS GOLDEN BEAR and TS STATE of MAINE: Naval Architechtrual and Marine Engineering Design and Plans for the new, Forward Marine Sanitation Device (MSD).

The intent of this task is to develop detailed work specifications and guidance drawings for the installation of new Marine Sanitation Devices (MSD) and the associated vessel modifications to handle sewage load from the forward deck house. This task shall be accomplished for two sister ships (nearly-identical): the TS GOLDEN BEAR and the TS STATE of MAINE. Separate specifications and guidance drawings shall be developed for each ship. One ship inspection/trip shall be conducted, first commencing with the TS GOLDEN BEAR (docked at the California Maritime Academy in Vallejo, CA) then continuing on to the TS STATE of MAINE (docked at the Maine Maritime Academy in Castine, Maine).
