1 STATEMENT OF WORK

STATEMENT OF WORK

TITLE: Develop Drawings and Specifications for Second Deck Berthing Upgrade aboard T.S. State of Maine

BACKGROUND and INTENT:

The TS State of Maine is a U.S. Government owned training ship provided to the Maine Maritime Academy for the purpose of training young men and women for a career in the U.S. Maritime Industry.

It is the intent of this Statement of Work (SOW) for a Contractor (Naval Architect) to provide specifications and ABS/USCG stamped approved, detailed drawings, necessary for a contractor to accomplish a complete upgrade of the second deck, 98 person, berthing area of the ship. This upgrade shall involve increasing the number of berths from 98 to 102. In addition, it shall involve the upgrade of all existing furnishings (bunks and lockers), joinery, overheads, decking, shower/toilet facilities and HVAC (heating, ventilation and air conditioning) systems.

At a minimum, design criteria shall be in accordance with the requirements of 46CFR167 and SOLAS requirements for a Cargo Ship (other than tanker). Additional requirements shall be at the discretion of the Port Engineer.

LOCATION:

The Training Ship State of Maine is currently located pier side at the Maine Maritime Academy, Castine, ME 04421. The berthing area to be upgraded is located on the 2nd deck between frames 104-75.

PERFORMANCE PERIOD:

This SOW can begin immediately after award. Delivery of stamped approved drawings shall be no later than November 1, 2010. Access to the ship shall be from 0700 to 1700, Monday thru Friday exclusive of federal holidays.

DESCRIPTION:

CLIN 0001: Provide Specification and Drawings

The Contractor shall provide all labor and materials to accomplish the following:

1. Perform a thorough survey of the second deck berthing area and the ship's drawings in order to determine the actual as built installations of the area. (Ship's crew shall be available to remove overheads and panels, as necessary, to aid in determining the actual location of services ((electrical, plumbing and ventilation)).
2. Based on the actual, as built installations and guided by the proposed, general arrangement sketch entitled "2 DECK BERTHING AREA (102 PERSONS)", develop guidance drawings to accomplish an upgrade of this area. This upgrade shall involve the following:
 - a. Removals of all existing fixtures (bunks and lockers), toilet facilities (showers, sinks and toilets), joinery (bulkheads and doors), decking materials and false overheads (hung ceilings).
 - b. Redesign of existing fresh water, black water and grey water piping systems to accommodate the proposed general arrangement sketch entitled "2 DECK AREA (102 PERSONS)". Existing black and gray water drains may need to be resized and/or re-sloped. In addition, this piping needs to be redesigned to provide accessibility for piping maintenance and cleaning.
 - c. Installation of new fixtures (bunks and lockers), toilet facilities (showers, sinks and toilets), joinery (bulkheads and doors), decking materials and lighting. It is desired to leave the overhead exposed (i.e., no dropped ceilings).


- d. Redesign of HVAC system serving this space to provide true air conditioning. Existing system does not provide for outside air mixing and proper temperature/humidity control.
 - e. Redesign of electrical systems. Lighting and 120 volt outlets shall accommodate cadets' academic requirements relative to lap top use (to include server connections) and reading needs. The existing PA system and phone system shall be redesigned to provide communications between the 2nd deck berthing compartments and the rest of the ship.
 - f. Redesign of fire detection. The ship's fire detection system shall be redesigned (via a separate contract) to permit addressable detector heads throughout the ship. A redesign of the detection system in this berthing area shall accommodate the addressable heads.
3. Provide the guidance drawings described in #2 above to the Port Engineer for review and critique.
 4. Upon approval of all guidance drawings by the Port Engineer, develop specifications and detailed drawings for an upgrade of the second deck berthing area. The detailed drawings shall be to scale and shall include, at a minimum, the following:
 - a. Rip out drawings.
 - b. Structural drawings including detailed foundations, fabrication details, locating dimensions, installation details (to weld to existing ship structure), welding symbols, and a complete material list with material descriptions, quantities and material specifications as well as sources for the material.
 - c. Electrical drawings including installation details, one line diagrams, equipment wiring details, cable sizes, cable types, watertight penetration details, and a complete material list.
 - d. Piping and HVAC drawings including all penetration details and a material list with material descriptions, quantities and material specifications as well as sources for the material. Additional views, sections, elevations and details as necessary for clarification.
 - e. Modifications to the ship's Fire Plan, and any other drawing or document required to be developed, modified and/or approved by the regulatory agencies as a result of this executing the upgrade.
 5. Provide all detailed drawings and specifications to the Port Engineer for review and critique.
 6. Upon approval of the detailed drawings by the Port Engineer, submit all drawings to ABS/USCG for approval. If necessary, resubmit revised drawings and specifications to satisfy regulatory questions and comments.
 7. All ABS drawing review charges shall be to the Contractor's account.

“Place of manufacture” means the place where an end product is assembled out of components, or otherwise made or processed from raw materials into the finished product that is to be provided to the Government. If a product is disassembled and reassembled, the place of reassembly is not the place of manufacture.

“Restricted business operations” means business operations in Sudan that include power production activities, mineral extraction activities, oil-related activities, or the production of military equipment, as those terms are defined in the Sudan Accountability and Divestment Act of 2007 (Pub. L. 110-174). (a) Inspection/Acceptance. The Contractor shall only tender for acceptance those items that conform to the requirements of this contract. The Government reserves the right to inspect or test any supplies or services that have been tendered for acceptance. The Government may require repair or replacement of nonconforming supplies or reperformance of nonconforming services at no increase in contract price. If repair/replacement or reperformance will not correct the defects or is not possible, the Government may seek an equitable price reduction or adequate consideration for acceptance of nonconforming supplies or services. The Government must exercise its post-acceptance rights—

(1) within a reasonable time after the defect was discovered or should have been discovered; and

(2) before any substantial change occurs in the condition of the item, unless the change is due to the defect in the item.

(b) Assignment. The Contractor or its assignee may assign its rights to receive payment due as a result of performance of this contract to a bank, trust company, or other financing institution, including any Federal lending agency in accordance with the Assignment of Claims Act (31 U.S.C. 3727). However, when a third party makes payment (e.g., use of the Governmentwide commercial purchase card), the Contractor may not assign its rights to receive payment under this contract.

(c) Changes. Changes in the terms and conditions of this contract may be made only by written agreement of the parties.

- (iv) Description, quantity, unit of measure, unit price and extended price of the items delivered;
- (v) Shipping number and date of shipment, including the bill of lading number and weight of shipment if shipped on Government bill of lading;
- (vi) Terms of any discount for prompt payment offered;
- (vii) Name and address of official to whom payment is to be sent;
- (viii) Name, title, and phone number of person to notify in event of defective invoice; and
- (ix) Taxpayer Identification Number (TIN). The Contractor shall include its TIN on the invoice only if required elsewhere in this contract.
- (x) Electronic funds transfer (EFT) banking information.

(A) The Contractor shall include EFT banking information on the invoice only if required elsewhere in this contract.

(B) If EFT banking information is not required to be on the invoice, in order for the invoice to be a proper invoice, the Contractor shall have submitted correct EFT banking information in accordance with the applicable solicitation provision, contract clause (e.g., 52.232-33, Payment by Electronic Funds Transfer-Central Contractor Registration, or 52.232-34, Payment by Electronic Funds Transfer-Other Than Central Contractor Registration), or applicable agency procedures.

Secretary of the Treasury as provided in Section 611 of the Contract Disputes Act of 1978 (Public Law 95-563), which is applicable to the period in which the amount becomes due, as provided in (i)(6)(v) of this clause, and then at the rate applicable for each six-month period as fixed by the Secretary until the amount is paid.

This paragraph does not give the Government any right to audit the Contractor's records. The Contractor shall not be paid for any work performed or costs incurred which reasonably could have been avoided.

(m) Termination for cause. The Government may terminate this contract, or any part hereof, for cause in the event of any default by the Contractor, or if the Contractor fails to comply with any contract terms and conditions, or fails to provide the Government, upon request, with adequate assurances of future performance. In the event of termination for cause, the Government shall not be liable to the Contractor for any amount for supplies or services not accepted, and the Contractor shall be liable to the Government for any and all rights and remedies provided by law. If it is determined that the Government improperly terminated this contract for default, such termination shall be deemed a termination for convenience.

(n) Title. Unless specified elsewhere in this contract, title to items furnished under this contract shall pass to the Government upon acceptance, regardless of when or where the Government takes physical possession.

(o) Warranty. The Contractor warrants and implies that the items delivered hereunder are merchantable and fit for use for the particular purpose described in this contract.

(p) Limitation of liability. Except as otherwise provided by an express warranty, the Contractor will not be liable to the Government for consequential damages resulting from any defect or deficiencies in accepted items.

(xi) 52.222-53, Exemption from Application of the Service Contract Act to Contracts for Certain Services-Requirements (FEB 2009) (41 U.S.C. 351, et seq.).

(xii) 52.222-54, Employment Eligibility Verification (JAN 2009)

(xiii) 52.226-06, Promoting Excess Food Donation to Nonprofit Organizations (MAR 2009) (Pub. L. 110-247). Flow down required in accordance with paragraph (e) of FAR clause 52.226-06.

(xiv) 52.247-64, Preference for Privately Owned U.S.-Flag Commercial Vessels (Feb 2006) (46 U.S.C. Appx. 1241(b) and 10 U.S.C. 2631). Flow down required in accordance with paragraph (d) of FAR clause 52.247-64.

(2) While not required, the contractor may include in its subcontracts for commercial items a minimal number of additional clauses necessary to satisfy its contractual obligations.

6 TEXTING WHILE DRIVING CLAUSE

CONTRACTOR POLICY TO BAN TEXT MESSAGING WHILE DRIVING

a) Definitions. The following definitions are intended to be consistent with the definitions in DOT Order 3902.10 and the E.O. For clarification purposes, they may expand upon the definitions in the E.O.

"Driving"-

(1) Means operating a motor vehicle on a roadway, including while temporarily stationary because of traffic, a traffic light, stop sign, or otherwise.

- (2) It does not include being in your vehicle (with or without the motor running) in a location off the roadway where it is safe and legal to remain stationary.
- "Text messaging" means reading from or entering data into any handheld or other electronic device, including for the purpose of short message service texting, e-mailing, instant messaging, obtaining navigational information, or engaging in any other form of electronic data retrieval or electronic data communication. (See definition in DOT Order 3902.10)
- (b) In accordance with Executive Order 13513, Federal Leadership on Reducing Text Messaging While Driving, October 1,2009, and DOT Order 3902.10, Text Messaging While Driving, December 30,2009, contractors and subcontractors are encouraged to:
- (1) Adopt and enforce workplace safety policies to decrease crashes caused by distracted drivers including policies to ban text messaging while driving--
- (i) Company-owned or -rented vehicles or Government-owned, leased or rented vehicles; or
- (ii) Privately-owned vehicles when on official Government business or when performing any work for or on behalf of the Government.
- (2) Conduct workplace safety initiatives in a manner commensurate with the size of the business, such as-
- (i) Establishment of new rules and programs or re-evaluation of existing programs to prohibit text messaging while driving; and
- (ii) Education, awareness, and other outreach to employees about the safety risks associated with texting while driving.
- (c) Subcontracts. The Contractor shall insert the substance of this clause, including this paragraph (c), in all subcontracts that exceed the micro-purchase threshold, other than subcontracts for the acquisition of commercially available off-the-shelf items.
- (End of clause)
