SECTION H -- SPECIAL CONTRACT REQUIREMENTS

H.1 KEY PERSONNEL

(1) During the first ninety (90) days of performance, the Contractor shall make no substitutions of key personnel unless illness, death, or termination of employment necessitates the substitution. The Contractor shall notify the Contracting Officer within 15 calendar days after the occurrence of any of these events and provide the information required by the next paragraph below. **After the initial 90-day period**, the Contractor shall submit the information required by paragraph (2) below, to the Contracting Officer **at least 15 days prior** to making permanent changes.

(2) The Contractor shall provide a detailed explanation of the circumstances necessitating the proposed substitution(s), **complete resumes for the proposed substitute(s), and any additional information requested by the Contracting Officer.** Proposed substitutes should have comparable qualifications to those of the persons being replaced. The Contracting Officer will notify the Contractor within 15 calendar days after receipt of all required information of the decision on substitutions. The contract will be modified to reflect any approved changes of key personnel.
